The Refugee Resettlement Program provides reception and placement services, including cultural orientation, cash assistance, case management, preventive health screening and health education, and employment and social services. The services are for newly arrived refugees, asylees, parolees, victims of human trafficking and special immigrants from Iraq and Afghanistan. The resettlement program assisted 1,281 persons and the Refugee Health Program served 1,895 persons for the year ended June 30, 2012.

Senior Services includes Foster Grandparents and Senior Companion programs which provide meaningful opportunities for retired seniors who are on a fixed income to volunteer and make an impact in their communities. During the year, a combined total of 117 Foster Grandparents and Senior Companions served 972 children, at-risk youth, and frail seniors. The Senior Residential Services program provided social and support services to 829 seniors/disabled adults living in senior housing. The Senior Nutrition program located in Imperial County provides a nutritious lunch for persons 60 years of age and older. The 9 congregate sites provided 54,709 meals to 1,352 seniors for the year ended June 30, 2012. In addition, over 292 homebound seniors had 44,662 meals delivered to their homes during the year.

Homeless Women's Services- provides a continuum of services for homeless women in San Diego and Imperial Counties. The program assists homeless women by moving them from homeless to shelter, with opportunities for work readiness training, transitional and permanent housing. The continuum, in 8 locations, includes a drop-in day center, night shelter, transitional housing, and independent living apartments and permanent housing. Approximately 3,493 women and 75 children used these services for the year ended June 30, 2012.
