The Foundation works in partnership with the University of Alaska's campus development offices to increase private support of programs and projects that are important to the University's 16 campuses, and to Alaska. Foundation staff support and serve the campus development staff in identifying, cultivating, soliciting, closing and stewarding private gifts. The Foundation solely manages the funds entrusted to it for the benefit of the University. In addition, the Foundation manages the investable assets of the University's Land Grant Trust Fund. The Foundation is responsible for gift acceptance, gift investment, and gift disbursement to the University. Great care is taken to ensure gifts are used in accordance with donor's wishes. More than 1400 separate named and endowed funds are managed and invested for the benefit of the University. In 2012, the Foundation distributed \$13.7 million for the benefit of the University. Included in this amount was \$2.9 million distributed for more than 2167 scholarships awarded by the University of Alaska.
