THE SCHOOL PROVIDES INNOVATIVE SPECIAL EDUCATION PROGRAMS FOR STUDENTS FROM AGE 7 THROUGH 21 WHO DISPLAY MODERATE TO SEVERE SPECIFIC LEARNING DISABILITIES (SLD) AND RELATED DISORDERS. THE ACID TILLOTSON SCHOOL IS LICENSED BY THE PA DEPARTMENT OF EDUCATION AND APPROVED BY THE BUREAU OF SPECIAL EDUCATION (BSE) TO PROVIDE SPECIAL EDUCATION SERVICES TO STUDENTS WHO ARE UNABLE TO RECEIVE APPROPRIATE EDUCATION PROGRAMS IN THE PUBLIC SECTOR.
