These 3 houses are now being leased to own at a discounted rate to qualified families. Also, during the fiscal year, repairs were made to 5 other houses in the Fountain Square neighborhood. In fiscal year ended June 30, 2012, three of the houses constructed in the 2010 Legacy Build have been sold to the renting homeowners at fair market value based on appraisal. As of June 30, 2012, Fuller Center has six mortgages and are renting five houses. All the mortgages are for approximately 20 years at no interest and all the rent to own are at a discounted rate to qualified families.
