Part III Statement of Program Accomplishments of Eagle Wings Academy (EWA)

EWA exists to offer a Christ-centered, Biblically-based education to urban children. EWA equips and supports students to reach their God-given potential and break free from the cycle of generational and spiritual poverty. EWA served 26 children (double from last year) from substantially minority/poverty backgrounds. The children ranged from Kindergarten through ninth grade. EWA continues to provide them with a quality Christian education with a ratio of 1 teacher/volunteer per 3 students. The students were provided 200 days (including Summer School and After School) of quality education. The children had Bible Lessons daily and Chapel once per week. The children went on outings once or twice a month (e.g., swimming, park, historical locations, community activities).. Lunches were provided twice per week. The children are assessed on a regular basis to assure progress and development. The older students receive career guidance and assistance. EWA has completed its fourth full year and continues to receive encouragement from various supporters.

Our students continue to receive support and assistance to help them overcome behavioral issues and to reach their full potential.

Presently, the Syracuse City School District has four High Schools whose recent graduates range from 0.8% to 12% ready for college. We are positioned to help our children be prepared for the careers they plan in the future.
