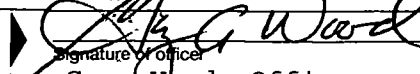

Additional grant funds of \$2,500 were received in addition to \$20,285 in rebates to augment the previous funding in order to complete the project.

The Sustainability Cities Institute provided grant funding in the prior year to conduct a meeting of the Urban Sustainability Directors Network. The costs reflect the expenses associated with the meeting held during this FY.

Program for Green Chips. The yearly event and ongoing community engagement brings together community to implement a "road map for sustainability." The program revenue includes Consumer Electronics Association, and expenses are those so far incurred for the event.
