IN SEPTEMBER 2011, OVER 150 DELEGATES ATTENDED REPRESENTING ROUGHLY 50 ORGANIZATIONS. GGJ COVERED COSTS OF TRAVEL, LODGING AND MEALS FOR MEMBERS PARTICIPATING IN THE ACTIVITY. THE COORDINATING COMMITTEE OF GGJ WAS ELECTED BY MEMBERSHIP. PROGRAMS FOR THE COMING YEARS WERE DEVELOPED AND APPROVED BY THE MEMBERSHIP. TOTAL EXPENSES WERE ROUGHLY \$70,000 FOR AIRFARE, LODGING, FOOD, LOCAL TRANSPORTATION, INTERPRETATION, CHILDCARE, AND MATERIALS.

CLIMATE CHANGE EDUCATION:

IN JUNE 2012, GGJ ORGANIZED A DELEGATION OF 16 GRASSROOTS LEADERS TO WITNESS THE UNITED NATIONS RIO+20 CONFERENCE ON SUSTAINABLE DEVELOPMENT AND TO PARTICIPATE IN A PARALLEL SUMMIT. THE PURPOSE OF THE DELEGATION WAS TO MONITOR THE DEBATES ABOUT CLIMATE CHANGE AMONG GOVERNMENTS AND MEET WITH PEOPLE FROM POOR COMMUNITIES AROUND THE WORLD WHO ARE EXPERIENCING DISPLACEMENT, LOSS OF AGRICULTURAL LAND AND LIVELIHOODS AS A RESULT OF CLIMATE CHANGE. TOTAL EXPENSES WERE ROUGHLY \$55,000 FOR AIRFARES, LODGING, LOCAL TRANSPORTATION, INTERPRETATION AND MATERIALS. GGJ ALSO HELPED ORGANIZE EDUCATIONAL ACTIVITIES IN 10 CITIES IN THE UNITED STATES ABOUT CLIMATE CHANGE THE IMPACT ON POOR COMMUNITIES THROUGHOUT THE WORLD. TOTAL EXPENSES WERE ROUGHLY \$10,000.
