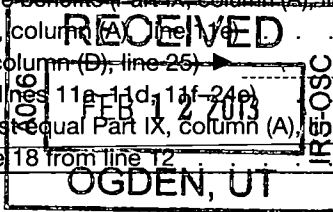

The morning classes consist of Math, Science, History and English. Hot lunch is served at midday and the afternoons consist of fine arts (band, chorus, art, theater/spoken word), study halls and athletics. Every Monday afternoon there is a chapel service. The summer program offers Math and English enrichment classes, basketball, art, cooking, and other activities. Overnight camping trips at Camp Alkulana and Jacob's Ladder complete the summer program.
