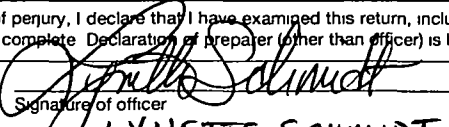

A seven-member governing board was elected in July 2011 and subsequently replaced founding board members. The FCC approved the transfer of broadcast licenses for KNOM in March 2012, followed shortly thereafter by the assumption of all assets, liabilities and operations of KNOM from Alaska Radio Mission, a subsidiary of the Diocese of Fairbanks.

 KNOM's mission is to inform, educate, inspire, and provide companionship for its listeners in remote Western Alaska. KNOM's listeners (numbering close to 20,000 people) are spread across 100,000 square miles; most live in villages spread along the Bering Sea Coast and eastward toward the Alaskan Interior.

 KNOM Radio Mission, Inc. successfully completed the FCC broadcast license transfer and assumed the operations of Alaska Radio Mission - KNOM (a subsidiary of the Catholic Bishop of Northern Alaska) in March 2012. While KNOM's former entity, Alaska Radio Mission - KNOM) was financially independent of the Catholic Bishop of Northern Alaska, a.k.a. CBNA, KNOM did not enjoy the autonomy afforded by an independent business relationship. The final stages of this separation from CBNA was accomplished in March 2012 with the initial step of FCC approval of the broadcast licenses transfer, then completed through the transfer of all assets of the subsidiary entity (Alaska Radio Mission - KNOM a.k.a. CBNA) to KNOM Radio Mission Inc.
 The legal expenses for this transfer and separation was borne solely by KNOM Radio Mission, Inc. These costs totalled \$9620 in FY 12.

 Newscasts: 2132/yr, educational/inspirational spots: appr. 50,000/yr, features: appr. 500/yr, weather reports: 8760/yr, current event call-in shows: 36/yr.
 KNOM produces local news & weather reports. For the majority of our listeners, KNOM is the only source available for vital local news & weather information. Additionally, KNOM's production team acts as a clearinghouse for educational material, including information on topics like health care, safety, and positive living. Most of KNOM's programming is produced locally - this means the final product is tailored to our audience, unique in many ways from any other population in the United States. This includes music aired, the variety of which reflects the interests of listeners, including an extremely large library of collected Native/local pieces.
 In recognition of service to the region in FY 12, KNOM received much-coveted National Association of Broadcasters' Marconi Award & Crystal Award, and the Alaska Broadcasters Association Goldie Award for Service to Community.

4c (Code:) (Expenses \$ including grants of \$) (Revenue \$)
 In spring of 2012, KNOM took on two major projects: installation of Dynamic Carrier Control (DCC) to KNOM's transmitter and plans to expand the broadcast studios to include digital production equipment. The former was completed in May, 2012 and resulted in a 3 month pay-back of the funds invested, and now saves KNOM an average of \$101 on electricity each day (\$36,865 annual estimate). Much of the cost was borne by KNOM's former entity, Alaska Radio Mission, but some was carried by KNOM Radio Mission. Thus, The pay-back was calculated on the combined entities' costs for the project.
 The latter project is expected to take 3 years. In FY 12, \$41,650 in capitalized costs were invested in the the design phase of the digital expansion project and \$963 for State Fire Marshall inspection of the related drawings. \$51,650 was raised for this project in FY12 by KNOM Radio Mission, Inc. and \$185,547 was received by KNOM Radio Mission, Inc. from donations intended for this purpose by Alaska Radio Mission, KNOM's former entity.

KNOM broadcast licenses and operations were transferred from Alaska Radio Mission - KNOM, a subsidiary of the Catholic Bishop of Northern Alaska, to KNOM Radio Mission, Inc. in March, 2012. The sale documents were signed in mid-March, 2012.

Part III, line 2

In April 2012, KNOM finally settled a 2-year legal dispute between KNOM (plaintiff) and North Mail (defendant). This lawsuit charged North Mail with breach of contract in 2008 when the bulk mailer was supposed to be distributing KNOM's newsletter and new donor acquisition appeals. Much of the cost of this litigation was borne by KNOM's former business entity (Alaska Radio Mission-KNOM, a.k.a. CBNA), but the final legal costs (\$2650) were paid by KNOM Radio Mission, Inc. The final settlement was paid to KNOM Radio Mission, Inc. (\$357,168), which is reported in Part VIII, line 11a, as related exempt function revenue because these funds were offered in remediation for work not performed for KNOM's former business entity.

The KNOM Board of Directors has a conflict of interest clause in it Bylaws. This clause is reviewed annually by the Board of Directors, at which time board members sign a conflict of interest statement.

Part VI, Section B, line 15 a & b

The KNOM Board President was charged with negotiating the compensation contract for KNOM's general manager position and development director/business manager position after receiving input from other board members' research of comparable compensation data.

At this time, KNOM was still operated as a subsidiary of the Catholic Bishop of Northern Alaska, and would continue as such for another 8 months. At no time were the founding board members in a supervisory position of themselves. The application for licenses transfer was filed with the FCC in late fall 2011, but not approved until March of 2012. Soon thereafter, KNOM and its assets were purchased from the Catholic Bishop of Northern Alaska (a.k.a. Diocese of Fairbanks).

Norman Schmidt, Kelly Brabec, and Lynette Schmidt were the founding members of the KNOM Radio Mission, Inc. board of directors. At this time, they worked for Alaska Radio Mission - KNOM, a subsidiary of the Catholic Bishop of Northern Alaska (a.k.a. Diocese of Fairbanks.)

The 4-page black and white printout depicts KNOM's activities & current program highlights. It is mailed to KNOM supporters who often return the business reply envelope with a donation. The publication is more of an advertisement of KNOM activities, thus, this expense has a separate line item in the chart of accounts, but included as a programs expense, not for fundraising.

SCHEDULE O ADDENDA

In January/February/March 2012, KNOM hired a professional firm to perform a full audit of the corporation's financial records. It was the intent of the Board of Directors to insure that financials, particularly the valuation of assets and accounting methods for the operations were set on firm ground. Thus, an audit was performed for the corporation for fiscal year 2012. Any changes to this form 990 are the direct result of consultation with professional auditors.

Part IV - line 12b

The audit was performed in Jan/Feb/Mar. Fiscal year 2013 audit is planned for late summer 2013.

Part VIII

Changes to the contributions by related organizations reflect the new property valuations, as set by the audit. Also included is \$24,560 13 in in-kind contributions from KNOM's contracted volunteer staff. These volunteers are unique in that they are required to live in KNOM housing, receive a small stipend and medical benefits. (Compare to community volunteers are not contracted, work minimal hours, and receive no benefits for their labors.) Contracted volunteer in-kind contributions are calculated thus:

$$\text{timesheet hours} \times \text{commensurate wages} = \text{monthly wages less stipend and expenses} = \text{monthly in-kind contribution.}$$

This contribution is likewise expensed as non-payroll staff benefits. These changes were affirmed by audit.
