The grant covered MLR's costs related to: 1) stewardship/monitoring of the conservation easements it held and monitored in 2011 (\$278,381); 2) outreach activities to educate landowners, public officials, and the general public (publications, travel, printing) (\$131,425); and 3) legal and contract expenses incurred with existing conservation easements and work completed on new projects in 2011 (\$12,047).
