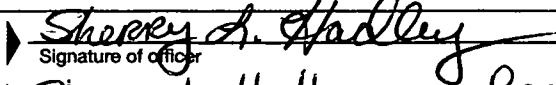
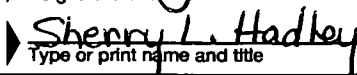

Working with our partner organization, Transformation Love - Ethiopia and with local Churches Mekanisa Addis Kidan Baptist Church we

Provide food, clothing, health care, education, and sometime housing for sponsored children. This also helps the entire family. During our

year 2011 we helped 105 children and their families.

We also provided grants for training and sewing business start ups. We help them maintain a facility to do business from and equipment
and materials for these businesses. We sent a total of \$81226.61 to Ethiopia during Fiscal year 2011/2012

Funds also contributed to help older students attend college and for the purpose of our partner organization development in Ethiopia.

Part 1 line 16 was spent on travel costs for board members to make trips to Ethiopia for the sole purpose of ministry development, checking
accountability of partners, and to minister to our beneficiaries. We also sent on board member Amber Hook to Ethiopia as a volunteer for
three monthes during fiscal year 2011/2012. \$12,453 was spent on travel expenses for those trips in fiscal 2011/2012.
