Successful Summer Cyber Camps are important to the schools purpose and mission as they are often the first contact students have with the school, its staff, and college level students who may work as camp tutors.

2 students completed the online Certificate III, IT course. This part-time Certificate III, IT is designed as an introductory course for people interested in learning basic skills in c++ programming. Students graduate with a introduction to the principles behind game programming techniques. Areas of study include: c++ programming, linear algebra and compiler (Microsoft Visual Studio) techniques.
