These short courses promote school exposure to the community it serves and is an introduction to courses students will enjoy at the college level. Successful Summer Cyber Camps are important to the schools purpose and mission as they are often the first contact students have with the school, its staff, and college level students who may work as camp tutors.

Areas of study include: c++ programming, linear algebra and compiler (Microsoft Visual Studio) techniques.
