**20 Liters invested in water testing equipment to determine which type of water filter would be the best in each area. Installation of sand water filters in Masaka, Rwanda, each serve 20 people. Investments for bicycles were made to make home visits, maintain the water filters, follow up with the recipients and assess the health of the recipient families. In addition, random evaluations were conducted of 40 of these households to identify areas for program improvement.**  
**Significant planning time was invested in planting and forming partnerships. This led to the development of a three year plan to install a clean water filter in every household without access to clean water along the Nyabovongo River. When completed, 20 Liters will have placed 40 rainwater cisterns, 31 SAM2 filters and 7,194 SAM3 filters and providing access to clean water to over 87,000 people. This phase is to begin in fiscal year 2012-2013.**
