FORM 990, PART VI, LINE 11B - FORM 990 REVIEW PROCESS

THE INITIAL DRAFT OF FORM 990 IS PREPARED BY THE ORGANIZATION'S CONTRACTED ACCOUNTANT AND IS GIVEN TO THE EXECUTIVE DIRECTOR AND ALL BOARD MEMBERS FOR INITIAL REVIEW. THE EXECUTIVE DIRECTOR NOTIFIES THE ACCOUNTANT OF ANY CHANGES TO MAKE. THE ACCOUNTANT MAKES THOSE REQUESTED CHANGES AND SUBMITS ANOTHER DRAFT COPY FOR THE EXECUTIVE DIRECTOR TO REVIEW. ONCE THE EXECUTIVE DIRECTOR APPROVES THE CORRECTED DRAFT COPY, THE ACCOUNTANT IS NOTIFIED TO PROCEED WITH COMPLETION OF FORM 990 FOR FILING. THE COMPLETED FORM 990 IS SENT TO THE EXECUTIVE DIRECTOR, WHO SIGNS AND DATES FORM 990 AND IT IS THEN FILED WITH THE INTERNAL REVENUE SERVICE.

FORM 990, PART VI, LINE 12C - EXPLANATION OF MONITORING AND ENFORCEMENT OF CONFLICTS

AT LEAST ANNUALLY, AND MORE OFTEN AS NECESSARY, EACH BOARD MEMBER IS REQUIRED TO COMPLETE A CONFLICT OF INTEREST DECLARATION FORM STATING IF ANY CONFLICTS EXIST AND THE NATURE THEREOF, OR STATING THAT NO CONFLICTS EXIST.

IF A BOARD MEMBER DETERMINES THAT HE/SHE HAS A CONFLICT OF INTEREST, THAT BOARD MEMBER IS TO ABSTAIN FROM ANY DISCUSSION AND VOTE ON THE SUBJECT MATTER.

IF A BOARD MEMBER BELIEVES THAT ANOTHER BOARD MEMBER HAS NOT DECLARED A REAL OR PERCEIVED CONFLICT OF INTEREST, THE BOARD MEMBER WITH THE REAL/PERCEIVED CONFLICT MAY BE ASKED TO CLARIFY THE SITUATION. IF A VOTE HAS BEEN TAKEN AND A BOARD MEMBER BELIEVES THAT ANOTHER BOARD MEMBER HAS A REAL OR PERCEIVED CONFLICT OF INTEREST AT THE TIME OF THE VOTE, THE MATTER WILL BE REVIEWED TO DETERMINE IF THERE IS A CONFLICT OF INTEREST AND IF A RE-VOTE SHOULD BE HELD.
