

Funds are used to provide the means, training and equipment to the members of the community who produce television programs through the Seal Beach Cable Television facility of interest to or about the community to air on the local cable television channel 3, which runs 24/7. In addition, these funds are used for production costs of live coverage of the local weekly government meetings in addition to a variety of community events such as concerts at our elementary school, high school, the Seal Beach Christmas parade and many other local events held in the city, including public access programming. Additional services provided include the daily playback of all programming on the channel and a video community bulletin board provided to and used by the community members.

Disbursements included in this category are amounts paid for the maintenance of the local studio and remote equipment, live and replay cablecasting and for providing facility, clerical and administrative services, operation and production costs to the Foundation.
