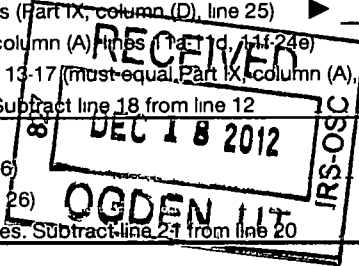

THE SCHOOL ALSO PROVIDES RELATED WORKSHOPS AND SUPPORT SERVICES FOR PARENTS AND EDUCATORS. IN RECENT YEARS THE SCHOOL HAS BEEN FILLED TO MAXIMUM CAPACITY. THE MAJORITY OF THE SCHOOL'S REVENUES IS TUITION (\$9,542,002 IN FYE 6/30/2012) (85% OF TOTAL REVENUES).
