At the completion of the review process, the Form 990 is presented to our full Board of Trustees for comments. After this, the Form 990 is submitted to the Internal Revenue Service.

Form 990, Part VI, Section B, Line 12c - On a yearly basis, all board members and officers of the organization are required to review our conflict of interest policy. Also, on a yearly basis board members and officers are required to disclose any possible conflicts of interest in a signed statement. All possible conflicts of interest are reviewed at the Board level. If it is determined that a conflict of interest exists, that individual is excused from any actions that could be influenced by that individual. Also, administration maintains records of where board members work to ensure if any business is transacted with that company it is at arm's length.

Form 990, Part VI, Section B, Line 15 - The Compensation Committee of our Board of Trustees sets the salaries of the President and Executive Vice President of OCPM. They meet annually and use comparative tools such as Form 990 data from other institutions, salary studies performed by third parties, performance measures, etc. to set the salary level of these individuals. The Vice President of Finance, Vice President and Academic Dean, and Clinical Dean have salaries set using the same information, however, the President and Executive Vice President perform the analysis and set the salaries. This process was last completed in June 2011 for the President and Executive Vice President and in May 2012 for other officers.

Form 990, Part VI, Section C, Line 19 - Ohio College of Podiatric Medicine will furnish our governing documents to an interested party upon written request from that party. Our Form 990 is made public through submission to trade and nonprofit websites. Also, upon request, our Form 990 will be sent to anyone.

Form 990, Part XI, Line 5 - The negative net assets of the taxpayer's subsidiary, Podiatry Associates of the OCPM (tax ID 34-1597797) were transferred to the taxpayer when the subsidiary ceased operations on June 1, 2012. This amounted to a reduction in net assets of 103,274. Also, the accumulated difference in unrealized gains and losses on investments decreased net assets by 148,633 as of June 30, 2012. The combination of the above two items result in a net decrease in net assets from other items of 251,907.
