The Wilderness Center offers a variety of educational programs to area schools, and to adult and family participants. During our fiscal year ended June 30, 2012, a total of 7,221 students attended our school programs and a total of 6,862 individuals participated in our family programs. Our educational programs also include a weekly podcast that had more than 66,000 visits during fiscal 2012.

The Wilderness Center's facilities include our Interpretive Building which contains classrooms, meeting rooms, exhibits, a wildlife observation room and a bookstore/giftshop; our Astronomy Education Building which houses an observatory and the Fred F. Silk Planetarium, along with hundreds of acres of public hiking trails, picnic shelters and an observation tower. During our fiscal year ended June 30, 2012, over 52,000 visits were made to our Interpretive Building and thousands of individuals made use of our other facilities.

The Wilderness Center is also involved in a variety of land conservation programs and projects. These activities include a conservation easement program (9 easements totaling 1,327 acres were held at June 30, 2012); a revolving land fund (3 revolving land fund transactions were entered into during fiscal 2012) and a forestry program (27 land management plans were written during fiscal 2012).
