Pt II Line 17a: The Foundation has an on-going program for requesting donations by attending open houses at the various school buildings to solicit members and donations, by publishing an annual report that includes a letter from the president requesting donations and/or interested new members, and by putting articles in the local newspapers describing the programs they are currently funding at the schools.

The interest and dividends they receive each year (52% of support over the past 5 years) is received from monies invested that were received from donation solicitations over the past 25 years. There were annual phone solicitations and mailings to the community requesting donations. Monies raised were invested with the hope of achieving a level of investment income where the annual fund raising would not have to be so time-consuming.
