

AMENDED
ARTICLES OF INCORPORATION
OF
THE FGI FOUNDATION
(Formerly The Rimon XL Foundation)

FIRST: The name of the Corporation shall be The FGI Foundation (hereinafter, the "Corporation").

SECOND: The place in the State of Ohio where its principal office of the Corporation is located is in the City of Cleveland, County of Cuyahoga.

THIRD: The Corporation is organized and shall be operated exclusively for charitable, educational or religious purposes by conducting or supporting activities for the benefit of, to perform the functions of, or to carry out the purposes of the qualified organization specified herein. The Jewish Federation of Cleveland, or its successor, (hereinafter, the "Federation") is so specified. An organization is a "qualified organization" for purposes of these Articles only if it is described in Section 501(c)(3) and Sections 509(a)(1) or (2) of the Internal Revenue Code of 1986, as amended (hereinafter, the "Code"). If the Federation ceases to be a qualified organization, the Corporation shall be operated exclusively for the benefit of, to perform the functions of, or to carry out the purposes of one or more qualified organizations as shall be selected by the Board of Trustees of the Corporation.

Solely for the above purposes, the Corporation is empowered to exercise all rights and powers conferred by the laws of the State of Ohio upon non-profit corporations, including, but without limitation thereon, to receive gifts, devises, bequests and contributions in any form, and to use, apply, invest and reinvest the principal and/or income therefrom or distribute the same for the above purposes.

FOURTH: No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to the Corporation's Members, Trustees, officers or private individuals, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article THIRD hereof.

FIFTH: It is intended that this Corporation shall have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code and which is other than a private foundation by reason of being described in Section 509(a)(3) of the Code. These Articles shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly. The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to such extent as would result in the loss of its exemption from federal income tax under Section 501(c)(3) of the Code. No activity of the Corporation shall consist of participating in or intervening in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

SIXTH: The Members of the Corporation shall be divided into two classes: the Federation Member and the Donor Members. The respective rights of each class of Members shall be as set forth in the Code of Regulations of the Corporation. The Trustees of the Corporation shall be divided into two classes: the Federation Class and the Donor Class. The method of electing each class of Trustees shall be as set forth in the Code of Regulations of the Corporation.

SEVENTH: Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provisions for the payment of all of the known liabilities of the Corporation, distribute all of the assets of the Corporation exclusively for charitable, educational or religious purposes to the organization specified in Article THIRD if it is then a qualified organization. If such organization is not a qualified organization, the assets of the Corporation shall be distributed in such manner and to such qualified organizations as the Board of Trustees shall determine. Any of such assets not so distributed shall be distributed by the court of common pleas of the county in which the principal office of the Corporation is then located, exclusively for the aforesaid purposes of the Corporation, or to such qualified organization or organizations as said court shall determine.

EIGHTH: The affirmative votes of Members holding a majority of the voting power of the Members at any annual or special meeting of Members shall be required to adopt or approve the following actions:

- (i) Liquidation or dissolution of the Corporation;
- (ii) Merger, consolidation or transfer of substantially all of the assets of the Corporation; and

(11) Repeal, modification, amendment in whole or in part of, or in addition to, the Articles of Incorporation or Code of Regulations of the Corporation or the adoption of new Articles of Incorporation or a new Code of Regulations.

The notice of the meeting at which any such action is to be considered shall set forth the subject of such action.

NINTH: All references in these Articles to sections of the Internal Revenue Code shall be considered references to the Internal Revenue Code of 1986, as from time to time amended, and to the corresponding provisions of any similar law subsequently enacted.

TENTH: These Amended Articles of Incorporation shall supersede the existing Articles of the Corporation.
