The Ignatian Solidarity Network (ISN) is a national social justice organization inspired by the spirituality of St. Ignatius of Loyola. ISN promotes leadership and advocacy among students, alumni, and other emerging leaders from Jesuit schools, parishes, and ministries by educating its members on social justice issues, by mobilizing a national network to address those issues and by encouraging a life-long commitment to the "service of faith and the promotion of justice".

Public Education, Social Action & Advocacy Program- November 12-14, 2011, the Ignatian Solidarity Network hosted a three-day national conference in Washington, DC, for individuals affiliated with Jesuit universities, high schools, parishes and other ministries. This is an annual event (taking place since 1997, originally held in Columbus, Georgia) to commemorate the lives of the Jesuit priests and their companions killed at the Jesuit university in San Salvador, El Salvador in 1989, and others who were martyred while working for social justice throughout the world. Approximately 1,100 people attended the conference held at Georgetown University. The program included international and national keynote speakers, more than fifty workshop sessions on social justice issues from around the U.S. and the world. The final day of the conference included an opportunity for groups to visit Capitol Hill and discuss social justice issues with legislative representatives and senators.

Leader Development Training - January 13-15, 2012, the Ignatian Solidarity Network hosted a leadership summit for students from Jesuit colleges and universities and other Catholic partner universities. Approximately thirty students attended the three-day summit from twenty different universities across the United States. The summit built upon the annual Ignatian Family Teach-In for Justice and invited emerging leaders to deepen their understanding of "a faith that does justice" and strengthening their capacity to effect positive social change. Throughout the weekend, students explored the Social Change Model of Leadership, examined the life of St. Ignatius of Loyola and his call to service for the greater glory of God, engage with fellow campus leaders, and with the support of experienced facilitators, develop personal action plans to translate leadership skills into programs on campus.
February 17-19, 2012 - ISN hosted the High School Leadership Summit, convening emerging student leaders and faculty/parish chaperones from Jesuit high schools and parishes nationwide to deepen their understanding of "a faith that does justice," share ideas and resources for social justice programming, and become empowered to effect positive social change in their local and global communities. Throughout the three-day program, students explore The Student Leadership Challenge: Five Practices for Exemplary Leaders and the relationships between service, faith and justice. Communications & Networking - Through the use of our website, electronic communications, list serves, and social media, we provide a means for communication and collaboration amongst our members and the larger body of Jesuit-affiliated ministries working for social justice. Our website serves as a central means of information sharing, networking, and disseminates crucial information and education regarding emerging social justice concerns. During FY11-12, ISN saw a 400% growth in Facebook engagement. Our website (www.ignatiansolidarity.net) welcomed nearly 15,000 unique visitors.

June 19-21, 2012, ISN hosted the Ignatian Immersion Experience Coordinator Summit which provided a relevant space for Jesuit college and university immersion experience coordinators working in ministry, service learning/academics and student affairs to participate in meaningful reflection and discussion about their work to engage students in the "gritty reality of the world" (Kolvenbach, 2000, Santa Clara University). Highlights from the program included an opening keynote and dialogue with Charlie Currie, S.J.
