	<p>FOLLOWING THE 2011 MILESTONE DEBUT IN NEW YORK CITY'S CARNEGIE HALL, THE TOLEDO SYMPHONY CONTINUED PROVIDING AUDIENCES ACROSS NORTHWEST OHIO WITH THE MUSICAL BENEFITS OF A RESIDENT PROFESSIONAL ORCHESTRA AUDIENCES NEARING 260,000 TOOK IN OVER 350 MUSICAL PRESENTATIONS OF ALL SIZES DURING THE YEAR ONCE AGAIN, THE FY12 OPERATING BUDGET WAS BALANCED, DUE TO EXTRAORDINARY BRIDGE FUND SUPPORT WHICH WAS RAISED ALONG WITH NEW COMMITMENTS TO THE TOLEDO SYMPHONY ENDOWMENT FUND IN EXCESS OF \$1.2 MILLION YET, FINANCIAL PERFORMANCE TRAILS THE ARTISTIC AND EDUCATION ACHIEVEMENTS OF THE ENSEMBLE. WHAT FOLLOWS ARE HIGHLIGHTS FROM THE OFFERINGS OF THE SEASON, PARTICULARLY THOSE WHICH SHOWCASE THE ORCHESTRA'S EXTRAORDINARY ABILITY TO COLLABORATE WITH AREA EDUCATIONS, CULTURAL AND PERFORMING ARTS ORGANIZATIONS. IN APRIL, THE TSO COLLABORATED WITH THE UNIVERSITY OF TOLEDO COLLEGE OF ARTS ON A SERIES OF LECTURES, FILM AND EXPLORATIONS IN ANTICIPATION OF A PERFORMANCE OF "MUSIC FOR A TIME OF WAR," THE RE-CREATION OF A CONCERT PROGRAM SELECTED FOR PRESENTATION AT THE INAUGURAL SPRING FOR MUSIC FESTIVAL BY THE OREGON SYMPHONY CONDUCTED BY CARLOS KALMAR. HARKENING BACK TO THE TOLEDO SYMPHONY'S 2011 PERFORMANCE AT CARNEGIE HALL, THE CLEVELAND PLAYHOUSE AND THE CLEVELAND ORCHESTRA COLLABORATED ON THE PRESENTATION OF "EVERY GOOD BOY DESERVES FAVOUR." IN THE SAME MONTH THE TOLEDO SYMPHONY CONTINUES ENERGETIC EFFORTS TO SUPPORT THE ECONOMIC DEVELOPMENT OF THE REGION BY PARTICIPATING FREQUENTLY WITH FOREIGN GUESTS VISITING THE REGION TO ASCERTAIN ECONOMIC OPPORTUNITIES. CONSIDERED BY MANY TO BE ONE OF THE STRONGEST CULTURAL ASSETS OF THE REGION, THE TSO TAKES A RESPONSIBLE ROLE BY ACTIVELY ENLIVENING ECONOMIC DEVELOPMENT ACTIVITIES WITH MUSIC AS TEACHERS, TSO MUSICIANS ARE FULLY INVOLVED IN PRIVATE INSTRUCTION AND ACTIVE IN THE EDUCATIONAL VITALITY OF THREE YOUTH ORCHESTRAS WHICH SERVED 250 STUDENTS IN THE LAST YEAR FROM 60 DIFFERENT AREA SCHOOLS. THE EDUCATIONAL AND MUSICAL EXPERIENCES OF STUDENTS IN THE YOUTH ORCHESTRAS PROGRAM HAVE BEEN STRENGTHENED SIGNIFICANTLY THROUGH THE REGULAR PRESENCE OF PROFESSIONALS IN CLINICS AND MASTER CLASSES. SYMPHONY MUSICIANS ALSO SERVE AS ADJUNCT FACULTY MEMBERS AT BOWLING GREEN STATE UNIVERSITY, THE UNIVERSITY OF TOLEDO, HEIDELBERG COLLEGE, THE UNIVERSITY OF MICHIGAN AND MANY OTHER SCHOOLS AND UNIVERSITIES. IN ADDITION, FOR THE YOUNGEST MUSICIANS, THE TSO SPONSORS THE TOLEDO SYMPHONY SCHOOL OF MUSIC FOR THE INSTRUCTION IN THE SUZUKI METHOD FOR PIANO, VIOLIN, AND CELLO BEGINNING AT AGE 3. IT IS WIDELY BELIEVED THAT THE STUDY OF MUSIC AND DEVELOPMENT OF MUSIC SKILLS, RESULTS IN A MEASURABLE DEGREE OF SCHOLASTIC ACHIEVEMENT. IN ADDITION TO THE PRESENTATIONS OF CLASSICAL MASTERWORKS AND POPULAR MUSIC, THE ORCHESTRA ANNUALLY PERFORMS A SERIES OF CONCERTS IN CHURCHES ACROSS THE GREATER TOLEDO AREA, AND EXTENDS THIS PERFORMANCE SERVICE TO NEARLY 20 REGIONAL CONCERTS IN OHIO, MICHIGAN AND INDIANA OVER THE COURSE OF ANY GIVEN YEAR. THE TSO IS GOVERNED BY 65 MEMBERS OF THE TOLEDO ORCHESTRA ASSOCIATION, INC. BOARD OF TRUSTEES, 44 OF WHOM ARE VOTING MEMBERS AND 21 WHO SERVE ON THE ASSOCIATION ADVISORY BOARD. THE SYMPHONY ENGAGES A PROFESSIONAL ADMINISTRATIVE STAFF OF 20, MADE UP OF 12 FULL TIME EMPLOYEES AND 8 PART TIME EMPLOYEES WHO ARE TYPICALLY MUSICIANS WITH THE ORCHESTRA. THE OPERATING BUDGET OF \$5.8 MILLION IS COMPRISED OF 43% EARNED REVENUE, 24% ENDOWMENT, AND 33% CONTRIBUTED INCOME. A TASK FORCE ASSEMBLED OVER THE SUMMER OF 2012 EXPLORED INCOME AND EXPENSE SCENARIOS FOR THE ORGANIZATION AND REACHED CONSENSUS ON 10 INITIATIVES TO BE PURSUED OVER THE COURSE OF FY12 AND FY13, LEADING TO A \$500,000 BENEFIT FROM THE BOTTOM LINE IN LESS EXPENSE OR GREATER INCOME.</p>
