The University of Akron Foundation provided academic support to The University of Akron by helping to fund 12 lectureships, 8 academic chairs, 8 professorships, over 50 departments, 2 pre-college programs, The University Press, 13 internships, 7 centers, 4 archives, 11 fellowships and 5 institutes.

NOTE: The expenses listed above are net of \$1,725,700 in funds that were transferred to the Foundation by the College of Polymer Science and Polymer Engineering to establish a quasi-endowment for graduate assistantships. The gross amount of academic support The Foundation provided to The University of Akron during fiscal 2012 was \$4,459,821.

The Foundation assisted The University of Akron with funding for physical improvements of the campus. During fiscal 2012, this included a new building for the College of Engineering, renovation of the soccer stadium, continued support for the football stadium and Coleman Commons.
