PUBLIC SUPPORT HAS INCREASED IN RECENT YEARS AS SUPPORTERS HAVE CONTRIBUTED TO THE EXPANSION OF THE CHARIS HOUSE. AT THE SAME TIME, MARKET CONDITIONS HAVE CONTRIBUTED TO A DECLINE IN INVESTMENT INCOME, REDUCING THE LEVEL OF TOTAL SUPPORT. THE BOARD OF DIRECTORS IS ACTIVELY CONSIDERING OPTIONS TO INCREASE PUBLIC SUPPORT IN FUTURE YEARS.
