The Child and Family Development Center (CFDC) offers a unique program that provides a rich early childhood education to children between the ages of 2 to 5 years CFDC is the only 4-star quality rated center in the state evaluated through the Illinois Department of Human Services It is accredited by the National Association for the Education of Young Children (NAEYC)

The Teen Parenting Initiative Program (TPI) is a school-based birth to age three preventive program that provides comprehensive social service to teen parents and their young children TPI is currently serving over 400 teen-head families The program operates four days a week at seven different Chicago public high schools which include the following high schools Robeson, located in the Englewood community, Hyde Park, located in the Hyde Park community, Banner, located in south Chicago, Simeon, located in West Chatham, Kenwood, located in Hyde Park, Farragut, located in the Little Village community, and Simpson, located in the Little Village community TPI aims to prevent teen parents from dropping out of high school, while preventing secondary teen pregnancies and reducing the incidence of child maltreatment for their young children It also promotes school readiness for the at-risk children,

Teen Alliance is a small but highly intensive and individualized foster care program designed to provide care for a specialized female adolescent population This is a group of foster children with highly traumatic and disruptive pasts whose needs are greater than can be provided for in a traditional foster home setting These adolescents are placed in homes of dedicated professional foster parents who are hired by CCCS to provide an essential caretaking role CCCS staff monitor these foster homes and provide needed supports such as counseling, mentoring, life skills groups and other activities

Family Literacy Program - The counseling program utilizes licensed therapists to provide clinical services to children and their families These services are provided to children living in foster care which have experienced traumatic histories of abuse, neglect and disruption Additionally, the counseling program also works with families involved in other Chicago Child Care Society programs

HIV Program - Safe Life is an HIV/AIDS prevention/education program aimed at providing information to adolescents This program is staffed by an HIV specialist who is trained in the Red Cross Act Smart HIV/AIDS education curriculum The aim of Safe Life is to stop the incidence of HIV/AIDS and other sexually transmitted diseases among the youth population

Lan 80 - The Educational Support Program works with children who are at risk of dropping out of school as a result of academic, behavioral and attendance difficulties Each child is assigned an Educational Mentor who provides a combination of tutoring and mentoring services aimed at improving performance and setting the child on a path toward eventual High School graduation

Next Step is a college-readiness program with mentoring support for pregnant and parenting teens Next Step begins its college-readiness curriculum with teen girls and teen boys in their junior year of high school, continues services through high school graduation and provides limited assistance for them through college enrollment and first year attendance Mentors include older college-educated professionals who are established in their careers, and peer mentors who are teen moms and dads in college, along with Next Step staff The mentors work closely with the high school participants to offer a structured, interactive curriculum focused on preparation necessary for the teen parents' future of self-sufficiency

Extended Family - The Extended Family support program provides critical support to grandparents and other relatives who have unexpectedly assumed the care of children when birth parents are no longer able to do so A family support specialist is assigned to the family and provides assistance in obtaining financial and community support as well as eventual private guardianship The goal of this program is to stabilize families and keep children from entering the foster care system

Early Head Start - provides weekly in-home visits to pregnant moms and moms and dads who have children between the ages of 0 to 3 CCCS staff with backgrounds in early childhood education work with the teens to strengthen their knowledge of child development and encourage self-sufficiency in parenting and education
