The goal is to work with the families of origin in order to return the children to a safe and secure environment, or arrange for alternative permanent arrangements within 2 years.

During FY 2012, 76 women and their families were served during their un-planned pregnancies. Care included housing, referrals for medical care, professional counseling, and the supply of other basic needs free of charges, during, and up to 6 months following a pregnancy.
