The Early Childhood Education Program serves 3 through 5 year old children, preparing children for future success in school. The program uses The Creative Curriculum for Preschool to infuse literacy, math, science, social studies, critical thinking, and problem solving into lesson plans. Nearly 90% of programming is full-day and year-long, with a traditional Half-Day Head Start model also offered. The Family Child Care Home Network provides quality home-based care for young children through licensed providers in small group, home settings. Embedded parent and family services include adult literacy and ESL classes, parenting and child development workshops, family activities, and comprehensive social services utilizing the Strengthening Families model.

The center-based Infant Toddler Development Program provides full-day programming for children, ages 6 weeks to 3 years, utilizing The Creative Curriculum in safe and stimulating environments. The program responds to children's natural cues provides continuity of care, and fosters early development. The Parent-Child Home Program provides home visiting twice a week for families with children between 16 months and 3 years of age to increase verbal interactions, positive parental involvement, and language and pre-literacy development. Through Home-Based Early Head Start home visitors make weekly visits lasting 90 minutes using books and activities to engage young children and foster their development. Embedded parent and family services include literacy and ESL classes, parenting and child development workshops, family

The School Age Program serves children, ages 6 through 12. Options span a range of areas: fine arts, literature, computers, math and science, games, and sports. Long-term projects, cultural exploration, and leadership development are also included. The Youth Alternatives Program (YAP) is an after school and evening program for community youth, ages 10 through 18. Two service learning projects, two personal development projects, academic support and tutoring, leadership development activities, and youth employment opportunities are provided. Organized sports, fine arts, social service support, and recreational activities also are included. YAP creates avenues for youth to develop strengths, talents, leadership skills, and an ethic of service in a supportive, yet challenging environment.
