Ounce provides high-quality early childhood services for low-income children, birth to age five, and their families as well as services to pregnant women, through a multi-site network of Early Head Start and Head Start directly-operated programs, and partner and delegate agencies, in high-needs communities throughout the city and surrounding suburbs In fiscal year 2012, the Ounce directly operated two programs at the Educare School of Chicago, and one program at the Hayes Center, and subcontracted with six agencies at 16 geographically- and ethnically-diverse sites, serving more than 1,400 young children and pregnant women
