

### Statement Regarding Operations

The primary exempt purpose of the organization has been to provide support to Children's Memorial Foundation (CMF), the fundraising unit of Children's Memorial Hospital, both located in Chicago IL.

Prior to the fiscal year ending June 30, 2002, the Organization was responsible for providing all of it's own accounting and recordkeeping functions. This included the recording of all revenue and expense activity relating to the Organization in their own accounts, the recording of all revenues and expenses in their financial statements, the recording of all revenue and expense items separately for each fundraising event, the reflection of a "net" annual donation (generally receipts less expenses) to CMF, the preparation of their tax filing reflecting revenues and expenses in their own financial statements and the issuance of donor acknowledgement letters. The Organization considers these activities to be administrative and operational in nature.

During the fiscal year ended June 30, 2002, CMF assumed the majority of all administrative and operational functions of the Organization and is now providing these services. Thus, the Organization is no longer directly reporting the revenues and expenses on their financial statements or tax returns. All contributions to the Organization and all expenses incurred by the Organization are being recorded by CMF on a gross basis, are being accounted for in a segregated account and are being reflected in the annual financial statements and tax returns for CMF. In effect, the Organization is continuing to make similar annual donations to CMF as their exempt purpose and the nature of their fundraising activities haven't changed. Since CMF collects and retains all receipts, the excess over expenses is considered the Organization's contributions to CMF, a public charity. They are also responsible for providing acknowledgements to donors.
