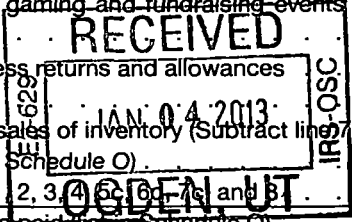

**Part III - Line 28 - Statement of Program Service Accomplishments:**

Through the operation of a thrift shop, The Hope Chest provides funding to the Constance Morris House ("CMH"), a domestic violence shelter and branch of Pillars. The thrift shop also donates meals, clothing and household items to the shelter as needed. CMH is an emergency residential shelter for women and children fleeing family violence. The shelter provides a clean, quiet, safe environment that allows a woman to think through her problems and assess possible solutions. The shelter can accommodate 25 women and children at any given time. The shelter also has a 24-hour crisis line and offers non-residential services, such as counseling, support groups, education about family violence for children and court advocacy through its parent charity, Pillars. There are no fees for CMH services. In the fiscal year ending June 30, 2012, The Hope Chest granted and paid \$12,000 to CMH, and paid for and delivered meals costing \$556 to feed residents.
