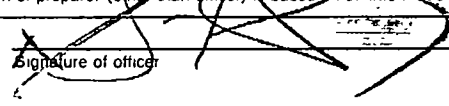

The Foundation has been part of this consortium since 2004 and successfully engaged more than 3500 teachers and impacted more than 30,000 students through its workshops and Primary Source Nexus website which continually highlights Library of Congress content including learning strategies and activities, technology tips and tutorial.

The Foundation developed and supports educational programs reflecting the values and traditions of the Sacred Heart. To achieve this purpose the Foundation sponsors scholarships and makes charitable contributions.
