HEAD START PROGRAMS FOR YOUNG CHILDREN HAS SERVED 482 CHILDREN AND FAMILIES IN A FIVE COUNTY SERVICE AREA, INCLUDING BOND, CLINTON, MARION, WASHINGTON, AND FRANKLIN. THE BCMW PROGRAM SERVES CHILDREN IN A 9 MONTH PROGRAM AND IN A FULL DAY/FULL YEAR PROGRAM. THE FULL DAY/FULL YEAR PROGRAM SERVES WORKING FAMILIES WHO NEED CHILD CARE. CHILD CARE SERVICES ARE LIMITED TO MARION COUNTY (CENTRALIA) AND WASHINGTON COUNTY (NASHVILLE). BCMW WAS ABLE TO OFFER SLOTS TO PARENTS WHO MIGHT NOT OTHERWISE HAVE BEEN ABLE TO AFFORD IT. THE FULL DAY/FULL YEAR PROGRAM SERVES ONLY FAMILIES IN A SITUATION WHERE THEY ARE BOTH WORKING. THERE ARE 77 CHILDREN AND FAMILIES WHO BENEFITTED FROM THE PROGRAM. BCMW ALSO OFFERS HOME BASED SERVICES TO 57 FAMILIES. THIS OPTION OFFERS EDUCATIONAL SERVICES IN THE HOME OF THE LOW INCOME HEAD

ENERGY ASSISTANCE TO LOW-INCOME INDIVIDUALS TO OFFSET COSTS OF WINTER HEATING BILLS AND WEATHERIZE HOMES OF LOW INCOME INDIVIDUALS. THE LIHEAP (LOW INCOME HOME ENERGY ASSISTANCE PROGRAM) IS DESIGNED TO ASSIST HOUSEHOLDS THAT ARE AT 150% OF POVERTY OR BELOW. THIS ASSISTANCE CAN COME IN THE FORM OF A ONETIME PAYMENT TO THE UTILITY COMPANY ON THE CUSTOMER/CLIENTS BEHALF TO ASSISTING A HOUSEHOLD TO GET UTILITIES RESTORED IN THEIR HOME IF THERE SERVICE HAS BEEN DISCONNECTED. TO EXPLAIN THE DIFFERENCE THE ONETIME PAYMENT GIVES THE CUSTOMER ASSISTANCE WITH THEIR MONTHLY BILL AND SOMETIMES THIS COULD BE UP TO TWO MONTHS OF SERVICES DEPENDING ON THE USAGE OF THE INDIVIDUAL. THIS IS CALLED A DVP (DIRECT VENDOR PAYMENT) AND IT IS FIGURED BY THE 30 DAY GROSS INCOME AND THE NUMBER OF INDIVIDUALS RESIDING IN THE

THE HOME PROGRAM HELPS LOW INCOME PEOPLE RECEIVE REHABILITATION WORK THAT NEEDS TO BE DONE TO THEIR HOME. WITHOUT THIS PROGRAM PEOPLE WOULD NOT BE ABLE TO AFFORD THE REPAIRS NEEDED TO THEIR HOME. AN ASSESSMENT IS DONE ON THEIR HOME AND THAT DETERMINES WHAT THE NEEDS ARE ON EACH HOME. THE WORK COULD INCLUDE ROOFING, FLOORING, DOORWAY REPAIRS, BATHROOM REPAIRS, OR ANY REPAIRS THAT NEED TO BE DONE TO THE HOME TO KEEP THE HOME OWNER IN THEIR HOME.

THE HOMEBUYER PROGRAM HELPS LOW INCOME FAMILIES BUY A HOME.
