GRANTS ARE ALSO MADE TO FULFILL DONOR RESTRICTIONS ON GIFTS MADE FOR CAPITAL IMPROVEMENTS AND OTHER PROJECTS. DURING THE FISCAL YEAR, THE FOUNDATION PROVIDED \$807,710 FOR OPERATIONAL SUPPORT, \$26,837 OF ENDOWMENT INCOME AND \$42,534 FOR DONOR RESTRICTED GIFTS USED FOR SPECIFIC PROGRAMS AND CAPITAL PROJECTS.
