Each year, following a specific formula, the Pine Rest Foundation awards grants to the Pine Rest Christian Mental Health Services to fund various aspects of behavioral health care and counseling programs. An award of \$391,124 was made to provide funds for financial assistance for patients with the inability to pay for services. An additional \$364,565 was made available for education, prevention and support programs throughout the Hospital. Funding was provided to support a research study and field testing for a new diagnostic screening tool (CAT-DI). The tool screens for depression, anxiety and bipolar disorders. Funding was provided for education and the implementation of treatment models for behavioral medicine within the outpatient network relating to psychiatric symptoms of common chronic illnesses (such as diabetes, high blood pressure, and heart disease). Funding was also provided for the execution of best practice models within three residential programs of the Hospital, Sensory Integration, Trauma Training and Gentle Teaching. A number of research, development and training programs were also funded.

Annual Golf Classic Fundraiser. The net proceeds from the Annual Golf Classic is put into a Foundation Endowment that builds each year. Then every 3-years, a three-year rolling average is taken to provide support to the Patient Assistance Fund, a program which provides financial assistance for patients with the inability to pay for services, or invested in order to provide additional support to Pine Rest.
