 General education contributions were used to pay for Delta College student scholarships, awards, educational programs, supplies and equipment. Contributions benefitted the entire Delta College community of approximately 19,100 students, faculty and staff. The Delta College Foundation also published and distributed two free magazines to residents living in the surrounding communities. The magazines provided valuable information about the programs and events at Delta College and included personal interest stories about the students, alumni, staff, donors and local businesses that either provided or benefitted from the opportunities available.

4b (Code:) (Expenses \$ 263,774 including grants of \$ 263,774) (Revenue \$ 0)
 Endowment fund contributions benefitted the entire Delta College community of approximately 19,100 students, faculty and staff as well as the surrounding communities. Endowment fund investment income provided approximately 180 scholarships and student awards during the fiscal year. This income also supports several college programs and projects such as Teaching Chairs, the Distribution Committee and the Possible Dream Program.

 Equipment and supply donations were primarily used to enhance educational programs at Delta College. The majority of this year's donations were used in the Technical Trades & Manufacturing Division benefitting nearly 2,400 students.
