KLF IS THE LARGEST PROVIDER OF FOOD ASSISTANCE IN KALAMAZOO COUNTY. THROUGH A PARTNERSHIP WITH TWENTY-SIX FAITH AND COMMUNITY-BASED SITES, KLF DISTRIBUTED SAME-DAY GROCERIES TO ELIGIBLE INDIVIDUALS ACROSS THE COUNTY.

IN THE 2011/2012 FISCAL YEAR, THE GPP DISTRIBUTED 1,393,567 LBS OF FOOD TO INDIVIDUALS AND FAMILIES ACROSS KALAMAZOO COUNTY. 112,418 INDIVIDUALS RECEIVED FOOD THROUGH THIS PROGRAM.
