



Tuition monies are not for specific individuals. Amounts allocated to these activities are determined each year by the board based on the value of assets held by the foundation.

Parish Support - funds provided to St Francis de Sales Parish and Our Lady of the Lake Parish to help support Catholic ministries and program directed by the parishes.

The maximum amount per request is 1,500. 10 requests were distributed for Our Lady of the Lake Parish programs. They included program support for Day of Sharing, Science Days, middle school retreats, Building Reading Fluency, Book Bag Connection, Teaching Reading Fluency, Assistive Technology and Celebrating American Curriculum. 4 requests were distributed to Saint Francis de Sales programs. They included computer equipment, audio/visual equipment and freezer. 3 requests were distributed to Our Lady of the Lake. They included classroom TVs, books and funding for Culture of Life program.
