Newark Public Schools Funders Collaborative - The Newark Public Schools Funders Collaborative provides a coordinated, strategic, and focused effort to increase the number and quality of school options that meet the diverse needs of Newark students. The Trust provides administrative support and analysis to the funders collaborative, which currently consists of nine funders who have collectively pooled funds into an investment fund to provide grants and assistance to public schools in the City of Newark. The funder's collaborative is currently supporting high quality district school options run by the Newark Public Schools. Beyond being a benefit to those schools receiving funding, the funders collaborative established a vehicle, framework, and governance model that aligns and coordinates resources on behalf of district reform strategies. The expenses included in the statement of functional expenses are the administrative costs incurred by the Trust to support the Newark Public Schools Funders Collaborative.

Research and Publications - Includes the development of the NET Navigator Program which maps external resources at the school level and provides a tool for public schools. NET Navigator was created to help funders, education leaders, and community stakeholders understand how university partnerships, philanthropic investments, and community engagements are impacting Newark Public Schools. NET Navigator does not evaluate or interpret the data it presents, rather, the tool is designed to empower funders, education leaders, and community stakeholders with information about existing relationships between investment dollars and student achievement.

Community Engagement - The Trust is committed to public engagement that includes all voices in support of quality public education for all Newark's children. The executive committee of the board met with the executive director to review the assessment and track progress toward goals. The entire board of directors was surveyed to add evidence and comment on performance. These comments were transcribed and patterns were identified that illustrated areas of strength and areas for growth. This information was then shared with the executive director as well as distributed to the entire board. Simultaneously, the board engaged in benchmarking salary guidelines across the sector in the region. The Council of New Jersey Grantmakers and other non-profit entities were consulted for salary guides. The executive director was then asked to develop an action plan and set goals for the coming year. These goals will be used to inform the next annual performance review and compensation discussion. The salary of the executive director was approved by the board of trustees.
