28 THE FOUNDATION PROVIDES RESOURCES TO WI 4-H YOUTH DEVELOPMENT PROGRAMS THROUGH GRANTS TO SUPPORT THE WORK OF THE COOPERATIVE EXTENSION-4H PROGRAMS, THROUGH KEY AWARDS, AND SCHOLARSHIPS FOR STATEWIDE 4-H PROGRAMS, AND FROM INTEREST EARNINGS FROM DESIGNATED ENDOWMENTS MANAGED BY THE UW FOUNDATION. DURING THE YEAR, THE FOUNDATION MADE SOME CHANGES IN ITS OPERATIONAL RELATIONSHIP WITH THE UW EXTENSION. THE FOUNDATION HIRED AN OUTSIDE DIRECTOR OF FUNDRAISING AND SUPPORT STAFF PERSON WHICH HAS INCREASED THE AMOUNT OF FUNDRAISING AND MANAGEMENT AND GERNAL EXPENSES THAT ARE FLOWING THROUGH THE FOUNDATION. IN ADDITION, THE CHANGE HAS ALLOWED FOR APPROXIMATELY \$36,380 OF GRANTS TO FLOW FROM UW FOUNDATION TO THE 4H FOUNDATION THAT WOULD HAVE PREVIOUSLY FLOWED THROUGH TO THE UW EXTENSION. ADDITIONAL GRANTS OF APPROXIMATELY \$56,000 WERE GRANTED OUT OF THE UW FOUNDATION FOR 4H RELATED PROGRAMS.
