ONE OF THE ORGANIZATION'S GOALS IS TO DEVELOP AND INFLUENCE LEGISLATION AND POLICY AFFECTING MEMBER FIRMS' BUSINESS. THE GOVERNMENT ADVOCACY PROGRAM HAS GROWN AND WE CONTINUE TO MOVE QUALIFICATIONS-BASED SELECTION PROCUREMENT LEGISLATION FORWARD. THE GRASSROOTS EFFORTS THIS PAST YEAR, WITH MORE THAN 300 CONTRACTS MADE WITH STATE LEGISLATORS, WAS HELPFUL, ALTHOUGH THE LEGISLATION FAILED TO PASS. WE WERE SUCCESSFUL IN OUR GRASSROOTS EFFORTS TO DEFEAT LEGISLATION THAT COULD HAVE SIGNIFICANTLY IMPACTED BUSINESS NEGATIVELY FOR THE INDUSTRY. MOST LEGISLATIVE OFFICES WERE CONTACTED BY THE MEMBERSHIP.

WE CONTINUED TO ORGANIZE ANNUAL CONFERENCES FOR CONSULTANTS WORKING FOR STATE AGENCIES AND TO HELP THE STATE COMMUNICATE ITS CONCERNS AND ISSUES TO WORK TOGETHER IN PARTNERSHIP. IN ADDITION TO QUARTERLY MEETINGS BETWEEN LIAISON COMMITTEES AND STATE AGENCIES, TWO LARGE CONFERENCES WERE ORGANIZED. IN NOVEMBER 2011, OVER 290 REGISTRANTS ATTENDED THE DIVISION OF STATE FACILITIES CONSULTANTS CONFERENCE. IT MARKED THE 18TH YEAR OF THIS EVENT. ALMOST THE SAME NUMBER OF PARTICIPANTS ATTENDED THE DIVISION OF TRANSPORTATION CONFERENCE HELD IN MARCH 2012. THIS CONFERENCE WAS THE SIXTH ANNUAL MEETING ORGANIZED BY THE ORGANIZATION WITH CONTINUED ATTENDANCE GROWTH.
