BIG BROTHERS BIG SISTERS OF AMERICA IS THE LARGEST AND MOST ESTABLISHED YOUTH MENTORING ORGANIZATION IN THE UNITED STATES BIG BROTHERS BIG SISTERS SERVES CHILDREN, AGES 5 THROUGH 18, IN COMMUNITIES ACROSS THE COUNTRY OUR AGENCY, BIG BROTHERS BIG SISTERS OF CENTRAL MINNESOTA, BEGAN IN 1969 THROUGH THE SPONSORSHIP OF AREA SERVICE ORGANIZATIONS TO HELP AT-RISK CHILDREN REACH THEIR FULL POTENTIAL (THE SON OF ONE OF OUR FOUNDERS IS PRESENTLY ON OUR BOARD OF DIRECTORS) WE SERVE ABOUT 600 -
