In fiscal year 2012, Plains Art Museum served 44,083 visitors of all ages through high quality art exhibitions, educational programs, live music, and outreach activities. The museum organizes six to eight major exhibitions annually with an equal number of smaller exhibitions. The museum's permanent collection of 3,800 objects is also used for special exhibitions and research, occasionally shown in national and international venues. Exhibitions focus on artists in the community and region. In fiscal year 2012, the museum presented the following exhibitions: Collectors, Humble and Extraordinaire; The Herbert and Dorothy Vogel Gift; Big Country FMVA Scale the Plains; Birch Bark, Clay, Pixels, Paint; New Work in the Museum Collection; See Acts of Audacious Daring!; The Circus World of Judy Onofrio; Cultivating Truth (S P A C E Sculpture); Thomas Rex Kemmer; Local Spots; Art = Food; Liz Miller; The Fredenck B Scheel Photography Collection; A New Gift to the Plains; You Like This; A Democratic Approach to the Museum Collection; Witness to Life; A Photo Journal of Hospice Care; Art on the Plains XII; Jubileum! Illustrations by Amy Jo Hendrickson; Flattum; The Birdhouse Project; The Missfit Cup Liberation Project; Responsive design by Michael J Strand; Margjone Schlossman; A Symphony of Color; Project Flood Diversion; A Creative Artistic Intervention Series; The Return of Sodbuster; Luis Jimenez in Fargo; Jon Offutt; Dakota Horizons; Pizza is a Vegetable; An Art = Food Installation by Lori Lorusso; The Green Line Series; An Environmental Art Installation by Stevie Famulan.
