Leadership Development:

1. System Level: MSUSA represents students interest with system wide policies regarding tuition, federal aid, academics, and other policies are reviewed and implemented. Also, MSUSA works with Minnesota State Colleges & Universities (MnSCU) staff on budgets and issues that affect students.

2. State Level: MSUSA represents students at the Minnesota State legislature, where policies and state funding are determined. Students frequently testify at the legislature about issues that affect them. Additionally, a large student rally is held at the capitol every two years.

MSUSA works with the Minnesota Office of Higher Education on financial aid issues involving MN State Grant and other aid program

MSUSA has established student coordinators on each campus who coordinate MSUSA efforts and events. MSUSA serves over 200 students each year at conferences held throughout the year

MSUSA's alumni association serves State University alumni in the areas of networking, advocacy, and mentoring. Alumni also conduct programs for current students.

MSUSA coordinated student groups from each campus in multiple state legislative visits and officers testified on several bills during the legislative session. MSUSA was successful in getting a bill passed which created a textbook work group charged with finding ways to reduce high costs that students pay for textbooks

On the federal level, MSUSA students make several trips to Washington DC to protect the Pell Grant, as well as make sure the student loan interest rates did not double on Stafford loans.

Scholarship Program: Two scholarship programs have been created to provide assistance to students. The Penny Fellowship Program provides assistance to students who choose low-paying or voluntary community and public service internships. Seven scholarships were awarded for the Penny Fellowship Program totally \$23,000. The Penny Fellowship Program is funded through foundations, contributions, and fund raising events.

The Jared Stene Leadership Scholarship Program provides monetary assistance to students with demonstrated leadership potential. The Jared Stene Leadership Scholarship Program is funded through contributions and fund raising events.
