	<p>Community Programs As part of our artist-led placemaking initiative Irrigate, we trained 275 local artists in placemaking and collaboration About 65 of those artists created 45 cross-sector projects with local businesses, community groups and non-profits The projects themselves involved dozens more artists and volunteers, and touched hundreds of viewers and participants The project collaborators have reported an increase in sales, exposure to new clients and community attention In our work with other cities to catalyze their creative communities, we have provided half-day or daylong workshops for 120 artists and creative entrepreneurs Community Supported Art (CSA) In FY12, the Community Supported Art program supported new work from 9 Minnesota artists, putting their art into 50 new households and creating a direct relationship between artist and patron This year we published a toolkit to help other communities replicate the program and traveled to several communities to assist their efforts There are now over 25 communities nationwide that have their own CSA program, based on our model Fergus Falls In July 2011, Springboard for the Arts opened its first rural office in Fergus Falls, Minnesota, to serve artists in the 9-County Lake Region of Minnesota and to create artist resources that are distinct to the area In FY12, we provided professional training, a resource center, legal and healthcare services to over 150 artists and consulted with 50 organizations, half of which were non-arts organizations Incubator Springboard for the Arts' Incubator A Fiscal Sponsorship Program provides fiscal sponsorship for arts groups and individual artist projects that do not want (or are not ready) to become tax-exempt nonprofit organizations In FY12, the Incubator program expanded by 56 new sponsorships, bringing the total number of Incubator participants to 175 We managed over \$1 million in revenues for the groups in the program Professional Development In FY12, Springboard for the Art's Professional Development programs connected with over 2,200 individual artists through workshops, one-on-one consulting and participation at leading conferences both locally and nationally In addition, Springboard for the Arts presented 124 workshops on business skills for artists, 220 hours of individual consulting and 8 conferences Theater Alliance In partnership with a group of theater representatives in Minnesota, Springboard for the Arts incubated the Minnesota Theater Alliance and provided assistance with staffing and other infrastructure needs At the end of FY12, the Theater Alliance received its own 501c3 status and officially spun off from Springboard for the Arts</p>

	<p>Artist Healthcare Springboard for the Arts supports artists' healthcare through several programs. Artists' Access to Healthcare (AAH) removes financial and system navigation barriers for artists and their families by providing artists with vouchers to cover the cost of medical, dental and mental health services. In addition to distributing 420 health vouchers to artists, Springboard for the Arts provided 54 free health screenings and 34 flu shots artists in Twin Cities. In addition, two other cities have replicated the AAH program based on a toolkit we recently published. In FY12, the Emergency Relief Fund (ERF) provided small monetary support for 9 artists who have chronic, often life-threatening medical conditions. We reached another 1,200+ artists through referrals and education Artist Resources. In FY12, Springboard for the Arts began increasing the size and capacity of our Resource Center for artists. Our computer workstations -- which are outfitted with scanners, Adobe Creative Suite, Microsoft Office, training software, a publications library, and other grant-making and opportunities databases -- had more than 100 uses in FY12.</p>
