RESOURCEWEST IS A SMALL NONPROFIT BORN OUT OF THE CONCERN OF COMMUNITY FOR ITS NEIGHBORS AND CONTINUES TO BE EMBEDDED IN THE COMMUNITY. COLLABORATION AND COORDINATION IS WHAT WE DO AND WE DO IT WELL. WE HAVE BEEN COLLABORATING WITH MANY DIFFERENT ORGANIZATIONS FOR NINETEEN YEARS. WE COLLABORATE WITH COMMUNITY PARTNERS CONNECTING INDIVIDUALS AND FAMILIES TO EXISTING PROGRAMS AND SERVICES TO MEET THEIR NEEDS. WE ARE A TRUE COMMUNITY ORGANIZATION. BY PARTNERING WITH A VARIETY OF LOCAL BUSINESSES, WE BROADEN OUR IMPACT IN THE COMMUNITY. WE CONTINUE TO CONNECT WEST METRO RESIDENTS TO COMMUNITY RESOURCES AND SUPPORT - THIS IS OUR DAILY MISSION. WE APPROACH EACH INDIVIDUAL AND FAMILY WHERE THEY ARE, MEETING THEM AT THEIR LEVEL OF NEED. WE ARE PROUD OF OUR EFFORTS TO NOT DUPLICATE SERVICES - WE COLLABORATE WITH AGENCIES TO PROVIDE SERVICES ALREADY OFFERED AND WE ARE ALWAYS ON THE WATCH FOR NEW SERVICES TO MEET THE COMMUNITY'S NEEDS. COLLABORATING IS ONLY A SMALL PORTION OF WHAT WE DO. WE HAVE PERSONALIZED SUPPORT SERVICES THROUGH OUR PROJECT STARFISH, JOB SEARCH ASSISTANCE THROUGH OUR COMMUNITY TECHNOLOGY CENTER, AND HELP FOR LOW-INCOME PARENTS WITH BACK-TO-SCHOOL SUPPLIES, WARM WINTER WEAR, AND HOLIDAY GIFTS THROUGH TOY CHEST. WE ALSO WORK WITH RELATE COUNSELING TO PROVIDE LIMITED FREE COUNSELING FOR CLIENTS WITHOUT HEALTH INSURANCE, HOST A HENNEPIN COUNTY ECONOMIC ASSISTANCE WORKER ONCE A WEEK, AND HOST MANY OTHER ORGANIZATIONS. WE ARE THE FIRST STOP FOR MANY PEOPLE IN OUR COMMUNITY FOR ASSISTANCE WITH THEIR SPECIFIC NEED(S). OUR SERVICES INCLUDE THE FOLLOWING: INFORMATION & REFERRAL - STAFF AND VOLUNTEERS ANSWER QUESTIONS ABOUT EVERYTHING FROM THE NEED FOR FOOD, CLOTHING, SHELTER AND HEALTHCARE, TO WHERE CHILDREN WILL BE GOING TO SCHOOL. WE ARE ALWAYS ON THE LOOKOUT FOR NEW SERVICES TO MEET THE NEEDS OF OUR COMMUNITY. WE PRIDE OURSELVES ON NOT DUPLICATING SERVICES, BUT COLLABORATING AND PARTNERING WITH OTHER AGENCIES TO REFER PEOPLE TO THEIR SERVICES. PROJECT STARFISH - OFFERS INTENSIVE, PERSONALIZED SUPPORT TO INDIVIDUALS AND FAMILIES TO HELP THEM IDENTIFY ISSUES AND SET PRIORITIES. COMMUNITY TECHNOLOGY CENTER - IS A SPACE STAFFED BY VOLUNTEERS FOR PEOPLE TO ACCESS COMPUTERS AND THE INTERNET TO HELP WITH RESUME/COVER LETTER WRITING, JOB SEARCHING, ONLINE JOB APPLICATIONS, COMPUTER SKILLS, RESEARCHING EDUCATIONAL OPPORTUNITIES, HOUSING RESEARCH, CHILD CARE SEARCH, AND OPENING E-MAIL ACCOUNTS. IT HAS SIX COMPUTERS WITH INTERNET ACCESS AND IS OPEN TO THE PUBLIC--NO INCOME LIMITATION. BACK TO SCHOOL - PROVIDING SCHOOL SUPPLIES IS ONE OF RESOURCEWEST'S ORIGINAL PROGRAMS. BEING SUCCESSFUL IN SCHOOL STARTS WITH HAVING THE BASIC SUPPLIES. WITHOUT THIS PROGRAM, OVER 1,100 CHILDREN FROM LOW-INCOME FAMILIES IN THE HOPKINS AND MINNETONKA SCHOOL DISTRICTS WOULD NOT BE PREPARED FOR THEIR FIRST DAY OF SCHOOL. THROUGH OUR BACK-TO-SCHOOL PROGRAM, EACH REGISTERED K-12 STUDENT RECEIVES A NEW BACKPACK FILLED WITH GRADE SPECIFIC BASIC SCHOOL SUPPLIES. WINTER WARM WEAR - KEEPING KIDS WARM THROUGHOUT THE COLD WINTER IS ESSENTIAL IN MINNESOTA. TOO OFTEN, WE SEE CHILDREN AND ADULTS BRAVING OUR TOUGH WEATHER WITH THE BARE MINIMUM OF WINTER OUTERWEAR - OR NONE AT ALL. THIS PROGRAM PROVIDES WINTER ESSENTIALS FOR MORE THAN 600 LOCAL CHILDREN FROM LOW-INCOME FAMILIES. THE PROGRAM IS FOR CHILDREN FROM NEWBORN TO AGE 18. EACH CHILD RECEIVES A WINTER JACKET, SNOW PANTS, WINTER BOOTS, A NEW HAT AND MITTENS. TOY CHEST - PARENTS CONTINUE TO STRUGGLE WITH INCREASING HOUSING, ENERGY, TRANSPORTATION, AND FOOD COSTS. FAMILY BUDGETS ARE STRETCHED THIN, SO PARENTS HAVE LESS MONEY AVAILABLE FOR HOLIDAY GIFTS. RESOURCEWEST'S TOY CHEST PROVIDES NEW GIFTS TO CHILDREN FROM LOW-INCOME FAMILIES. MORE THAN 1,200 CHILDREN BENEFIT FROM THIS PROGRAM. RESOURCEWEST PROVIDED REFERRALS AND INFORMATION TO OVER 10,000 PEOPLE IN OUR COMMUNITY. INDIVIDUALIZED PERSONALIZED SERVICES THROUGH PROJECT STARFISH TO OVER 600 PEOPLE. ASSISTANCE WRITING RESUMES AND JOB SEARCHING TO OVER 750 PEOPLE. OVER 800 LOW-INCOME FAMILIES THROUGH OUR CHILDREN'S PROGRAMS WITH ONLY 4 EMPLOYEES AND OUR BASE OF 350 COMMUNITY VOLUNTEERS (WHO ARE VITAL TO THE SUCCESS OF OUR MISSION). OVER 1,100 STUDENTS WITH BASIC SCHOOL SUPPLIES, WORTH OVER \$4,000. EMPOWERING SUCCESSFUL STARTS TO THEIR SCHOOL YEAR - OVER 600 CHILDREN WITH JACKETS, SNOW PANTS, BOOTS, HATS, AND MITTENS VALUED AT NEARLY \$37,000. SMILES TO OVER 1,200 CHILDREN WITH GIFTS VALUED AT \$71,500. WE FIRMLY BELIEVE WHEN PEOPLE CONNECT TO NEEDED RESOURCES, COMMUNITIES ARE HEALTHIER. WE SUPPORT COMMUNITY BUILDING THROUGH RESPECTFUL LISTENING AND WORKING COLLABORATIVELY TO ADDRESS IDENTIFIED NEEDS. WE CANNOT SOLVE EVERY PROBLEM PRESENTED TO US, BUT BEING HERE FOR OUR CLIENTS PROVIDES THEM WITH A LITTLE MORE COMFORT AND SUPPORT. OUR DAILY GOAL IS TO CONNECT PEOPLE TO NEEDED RESOURCES, HELPING TO SOLVE PROBLEMS WHILE STRENGTHENING THE FAMILIES, AND THUS THE COMMUNITY.
