- a) The dollar amount of your request
- b) The purpose for which the funds will be used; and
- c) Any special time constraints on the receipt of the contribution; such as, fiscal year end, capital or operating support campaign ending on a specific date, etc.

Page 2: Evidence from the Internal Revenue Service of your current 501(c)(3) status

Page 3-5 Any supporting documentation you wish to include.
