With the support of the McKnight and Jerome Foundations, the Playwrights Center provided fellowships to fifteen playwrights and theater artists last season. These include the five Many Voices fellowships for beginning and emerging playwrights of color, one of the only programs of its kind in the country that focus on providing educational support and career development, four Jerome fellowships that provide support to emerging professional playwrights, three McKnight Theater Artist fellowships that recognize the work of Minnesota artists, two McKnight Advancement Grants for established Minnesota playwrights, and one McKnight National Residency and Commission that supports nationally renowned playwrights and the development of a new play. These fellowships provide artists time and opportunity to focus on creating. The Playwrights Center functions as a home to these artists during their fellowship year, and all recipients are provided development funds to work in our Lab. Nobody is serving playwrights as well as the Playwrights Center. Nothing in New York compares. (Craig Lucas, former McKnight fellow)

The Lab is now one of the most prolific laboratories for new play development in the country. The Lab brings Core Writers, a group of 25-30 established, mid-career, and emerging playwrights from across the country and their collaborators (directors, dramaturgs, designers, and actors) together in Minneapolis to develop their work in 10-30 hour workshops. In 2011-12, we hosted a total of 59 play development workshops in our Lab, 23 of which were provided for our Core Writers. Some of those plays are chosen to be presented in the Ruth Easton New Play Series or PlayLabs, our season of public readings. In 2011-12, we produced five free staged readings of our Core Writers' and fellows' plays in the New Play Series and another four in PlayLabs. Developing work for the stages of local and national theater partners is also included in the work of the Lab. They always treat you professionally, pay their artists respectfully, and truly put their money where their collective mouths are in terms of serving the playwright and the development of the script. I would call the Playwrights Center my oasis if it weren't so cold there every time I visit. (Dan O'Brien, Core Writer)

The Center is one of the largest open-membership organizations for playwrights in the country. Individual membership (\$50/year) provides career development, networking, and access to resources. In FY12, the Center's 1,193 members took advantage of our online opportunities listings, and our staged reading, dramaturgy, and class programs. In addition to general membership, the Playwrights Center created New Plays on Campus (NPOC), an institutional membership program that works directly with colleges and universities to afford students the opportunity to develop their plays and to provide residencies and productions for playwrights. There were 42 NPOC schools in the 2011-12 season. This program actually works. It takes the best of many worlds and brings it all together. We love the New Plays on Campus program.
