Black Hawk-Grundy Mental Health Center, Inc. (the Center)'s mental health services program's objective is to provide a variety of mental health services to people in Black Hawk and Grundy Counties at no or low cost based upon a sliding fee scale.

During FY12, the Center's outpatient services provided over 22,400 initial evaluations, individual and group therapy and medication management services to approximately 5,300 individuals.

The Center provided assistance to homeless individuals in the form of evaluations, outreach services, assistance in accessing benefits and other provider services, funding for bus tickets and assistance in locating housing. In FY12, assistance was provided to 350 homeless individuals.

The Center provided school based mental health services to youth in the public schools. In FY12, 230 youth and family were seen for direct clinical care and group sessions on anger management, social skills and coping with depression were provided.

The Center provided outreach services to individuals with a serious and persistent mental illness in an effort to prevent or reduce hospitalizations and institutional placements while promoting independence in the community. In FY12, the Center provided over 7,000 outreach visits to approximately 500 individuals in their homes or in the community.

The Center provided home-based mental health services to individuals over the age of 60 who are at risk of placement in a more restrictive environment due to untreated mental and medical problems. During FY12, the Center provided services to 70 individuals over the age of sixty in their homes.

The Center provided peer support services through a Mental Health Recovery Center located in downtown Waterloo. The services were provided by consumers who have been trained to provide peer support with clinical oversight by a Licensed Social Worker. During FY12, seven trained consumers provided peer support services with over 5,000 contacts. Approximately 300 consumers visit the Recovery Center each month for information, referral, educational resources and support groups.

The Center provided nursing services to clients who needed medications. They provided telephone triage, pharmacy calls for new or renewal medications, access to pharmaceutical patient assistance programs, education and injections. During a typical week the nursing staff had direct contact with over 500 individuals. Currently over 1,300 clients receive free medication through these programs. During FY12 the Center's nursing staff placed patient assistance medication orders each month for free medication with an annual value of \$4 million.

Through a grant from the 1st Judicial Department the Center implemented the second Mental Health Court project in the State of Iowa in collaboration with the Black Hawk County Attorney and the State Public Defenders Office in July 2009. During FY12 the program worked with 45 individuals.

The Center also provided consultation and education services. In FY12, formal presentations were made to over 1,500 individuals in the community. Informal consultations and educational activities occurred daily.

The Executive Director evaluates and reviews compensation for key employees of the Center by using the same processes as the Personnel Committee. Any changes to the compensation of key employees are included in the annual budget which is reviewed and approved by the Board of Directors.
