IBA FCC Alternative Broadcast Inspection Program In cooperation with FCC, IBA has established the Alternative Broadcast Inspection program (ABIP) ABIP is a partnership with the Federal Communications Commission (FCC) to help stations ensure they are in compliance with FCC technical rules and regulations Under this program Iowa radio and TV stations receive an inspection from the IBA’s FCC approved inspector comparable to an official FCC field office inspection If the station is certified in compliance with FCC regulations, it is exempt from random/routine inspections by the FCC Field Office for three years The IBA/FCC ABIP operations operates pursuant to an agreement between the IBA and the FCC Enforcement Bureau During the 2011 Inspection Program, between August 1, 2011-December 2, 2011, a total of 233 Iowa radio television stations were served
